### **Carbon footprint**

Since 2021, we have been measuring the carbon footprint of our business activities and each of our projects on an annual basis. We note, among other things, the energy consumption of premises, fugitive emissions, transportation of staff members, business travel and IT equipment. Details will be published in an annual report to help us improve our ESG strategy to reduce our environmental impact.

### Water consumption

All our real estate projects incorporate measures to save drinking water, for example, the installation of low-flow appliances and rainwater irrigation where possible.

### **Energy efficiency**

We aim to reduce our energy consumption by installing LED lighting in all our properties under management and future initiatives, and by always choosing fixtures of proven efficiency.

### Residual materials management

Our aim is to incorporate recycling and composting into all the projects in which we are involved in terms of property management, thereby minimizing our waste production.

### Green spaces and biodiversity

We are committed to expanding green spaces at each of our sites and ensuring that biodiversity can thrive. Areas under development and redevelopment will include the addition of trees, shrubs and plants as well as a larger green area accessible to users.

### Responsible purchasing

A responsible purchasing policy is being drafted to meet today's social, environmental and economic challenges.

### Sustainable buildings
